TENDER FOR EXPRESSION OF INTEREST FOR UTILISATION OF RESOURCE FOR PRODUCTION OF TISSUE CULTURE PLANTLETS

West Bengal State Food Processing and Horticulture Development Corporation Limited (WBSFP&HDCL) has established a Tissue Culture Laboratory at Plot No.349/A, Vill-Ayeshpur, G.P.-Biorhi-I, Block-Haringhata, Dist-Nadia-741249 with a plinth area of 574.72 sqm approximately, in the short referred to as Ayeshpur T.C. facility has a media preparation room (6.1 m x 6.1 m), production room (12.2 m x 9.1 m), a checking room (5.5 m x 4.6 m) and three growth rooms of 7.6 m. x 6.1 m and 6.1 m x 6.1 m size. The T.C. Lab and associated facilities has a production capacity of about 30 lakh tissue culture plants annually. Necessary equipment and other furniture required like racks etc. are also available. Besides, Polyhouses of – 2992 sqm, 1232 sqm, & 880 sqm, are also available for hardening. A detailed inventory of assets, equipment, structures and machines is provided in Annexure-I. WBSFP&HDCL has decided to hand over the fully equipped facility for production and marketing of tissue cultured plantlets to a successful bidder, with its own Department of Biotechnology (DBT) accredited laboratory, on an 'AS-IS, WHERE-IS' basis. Interested agencies with duly accredited DBT laboratories are advised to visit the site at the abovementioned address. However, a visit to the facility is optional.

SALIENT POINTS OF THE BID:

1. Any and all Capital Expenditure and Revenue Expenditure required to bring the facility to an operational readiness shall be borne by the successful bidder,

- hereinafter called the Agency. The WBSFP&HDCL shall not bear any part of the said expenditure except for provision of power supply (including sub-station but not the wiring etc. within the laboratory), water supply and waste- water disposal.
- 2. Ownership of any and all existing installations and additional ones, including addition/modification of civil structures, equipment, fixtures, lab implements made or brought in by the Agency shall vest in WBSFP&HDCL through the period of the contract.
- 3. The contract period shall initially be for 4 years, and can be renewed for a further term of 4 years on mutually agreed terms and satisfactory performance in the first term.
- 4. The facility has a minimum production capacity of 30 lakh TC plantlets annually. The Agency should produce at least 11 lakh plantlet per year. The Agency shall bear full responsibility for the optimal usage of the said capacity and is free to use it for production of more plantlets.
- The Agency shall be free to produce any and all varieties of TC plants for which it owns or procures protocols;
- 6. The WBSFP&HDCL routinely procures of Tissue Culture Banana Grand Nain plants for distribution programme of the Department of Food Processing Industries & Horticulture, Govt. of West Bengal. For the purpose of sourcing Tissue Culture Plantlets, the WBSFP&HDCL will inform the agency, the quantity of T. C. Banana or any other plants it intends to procure from the Ayeshpur TC Facility within the month of January of any year during the contract period which may be produced at the facility. However the WBSFPHDCL shall buy back at least 10 lakhs Tissue Culture Banana or any other Tissue

- Culture plants which is being produced at the facility, from the agency.
- 7. As there will be minimum time required to operationalize the Ayeshpur TC Facility, the agency may produce the TC plantlets prior to primary hardening from its own DBT certified facility and then carry out primary and secondary hardening at Ayeshpur TC Facility before supply to the Corporation. This specific relaxation is given for the first year only.
- 8. In terms of point no. (6) above, the Agency on being duly informed in time by WBSFP&HDCL of its requirement, if any, shall procure TC Banana Grand Nain and any other TC Plantlets which can be produce at the facility. As per industry norms, the agency has to add 5% to the number requisitioned to cover any spoilage/transit damage. The agency has to produce a minimum of the this quantity at the Ayeshpur TC Facility.
- 9. Again in terms of point no. (4) and point no. (5) above, the WBSFP&HDCL shall pay the agency Rs 13.55 /TC Banana Grand Nain (Ex-Lab rate) for the 1st year of supply .The plantlets which will be purchased by Corporation shall be delivered by the agency at destinations communicated to them. The delivery charge will be borne by the Corporation and is not included in this price stated here. In all cases the distance will be calculated from the Ayeshpur farm. For other type of TC Plantlets, the price will be fixed by a committee formed for this purpose. The price of all TC Plantlets including those of T C Banana Grand Nain shall be escalated by the WBSFP&HDCL in each year by 10% compounded on the base price during the contract period.

- 10. Apart from the procurement by WBSFP&HDCL, the Agency shall be free to use the installed capacity to plan its production, and pricing thereof in case of sale to any third party.
- 11. No bid from any bidder shall be allowed if the said bidder or any of its partners or subsidiaries is engaged in any legal dispute with either the Department of Food Processing Industries and Horticulture or the Directorate of Horticulture or the WBSFP&HDCL, or any of its field offices. A duly notarized certificate to this effect will have to be provided by bidders at the time of document submission as well as at the time of contract renewal.
- 12. For any commercial transaction undertaken by the Agency with any third party, all legal and financial responsibilities shall rest with the Agency. The WBSFP&HDCL shall bear no part of it.
- 13. The Agency will not have any right to the property of the facility in any form or manner. It shall act as an 'Operations and Maintenance' (O&M) partner for the WBSFP&HDCL. Under no condition will the Agency seek to hypothecate the property of the facility or part thereof. However, the Agency may hypothecate the inventory of TC Plantlets produced.
- 14. All industry safety standards and statutory requirements shall be complied by the Agency. WBSFPHDCL shall not be liable for any violation of any safety standards or statutory requirement.
- 15. The Base Royalty for the facility has been fixed at Rs 20 lakhs /annum (TWENTY LAKHS ONLY PER ANNUM). Hence, the Financial Bids will start at above the Base Royalty, i.e. from Rs 20,00,001/-

- 16. The successful Financial Bid shall constitute the annual payment of the Agency to the WBSFP&HDCL, and shall be payable to the WBSFP&HDCL in four equal installments at the end of each quarter of a financial year that is on 30th June, 30th September, 31st December and 31st March every year.
- 17. In case of delayed payment, an interest of 2 % per month on due amount shall accrue as interest. However, this facility shall not be available for more than two months. Such continued default shall result in cancellation of the work order and forfeiture of the Security Deposit.
- 18. The bid will be a two stage bid, with the Financial Bids being opened of those bidders who have qualified in the Technical Bid. The evaluation of the valid bids will be on a QUALITY AND COST BASED SELECTION (QCBS) selection process.
- 19. The minimum score for passing the Technical Presentation shall be 50 out of a total of 100, on the parameters given subsequently in this document.
- 20. The weightages assigned for Technical Presentation and Financial Bid are 60% and 40%, respectively.
- 21. The Agency can use the land for production of the tissue culture plants but shall have no other rights on the land.

TWO BID SYSTEM

A. For Technical Proposal

The technical proposal shall contain the signed and scanned copies of the following-

Cover-I- This cover should be marked as Technical bid and should contain papers with covering letter on letter head of the bidder giving the detailed technical information as required vide Part-A of the tendered document.

The requisite documents are to be submitted in the respective folder of the E-Tender portal. Failure to submit any of the above documents may render the Bidder liable to be rejected without any further reference.

B. For Financial Proposal

The Financial proposal should contain-

Bill of Quantity (BOQ):-

- 1. The rate should specify royalty rate offered by the Agency as detailed vide BOQ of this tender.
- 2. Annexure- II for financial proposal will be uploaded in financial packet in pdf format.

The participant will be rejected in case the BOQ/Financial Bid is uploaded in the folder for Technical Bid or is otherwise disclosed.

The bids shall be evaluated on a 'QUALITY AND COST BASED SELECTION' (QCBS) method, with 60% weightage for Technical Bid, and 40% weightage for Financial Bid. The technical bid shall be evaluated against a of 100 marks, totaled over all the parameters. The financial quote of the highest bidder shall be assigned a mark of 100, and all the other bids shall be normalized against it. Both the technical bid and the financial bid will then be assessed by assigning the respective weightages against them.

Assessment of financial bid (the H-1 bidder) will be done on the basis of Net Present Value Method @ 6% discounting offered by the bidder for the whole tenure.

It must be noted that Financial proposal of a bidder shall only be opened in case the bidder qualifies in the Technical proposal. A bidder will qualify in the Technical bid only if he scores a minimum of 50% in the technical score.

1. BID PROCEDURE

a. **Registration of Bidder:**

Any bidder willing to take part in the process of e-Tender will have to be enrolled & registered with the **Government e-Procurement System / Portal**: http://www.wbtenders.gov.in

b. Digital Signature Certificate (DSC)

Each bidder is to obtain a Class-III or Class-III Digital Signature Certificate (DSC) for submission of tender from the approved service provider of the National Informatics Centre (NIC).

c. Collection of Tender Documents

The intending Bidders can search and download NIT and Tender Document(s) electronically / from the **Government e-Procurement System / Portal** using the Digital Signature Certificate. **This will be the only mode of collection of Tender Documents**.

d. Submission of Tenders

Tenders are to be submitted online on the website http://www.wbtenders.gov.in in two folders within the prescribed schedule using the Digital Signature Certificate (DSC). The documents are to be uploaded in the form of virus scanned copy duly signed. The documents will get encrypted (transformed into non readable formats).

e. Earnest Money Deposit (EMD)

Detailed procedure for online submission of Earnest Money Deposit (EMD)

Procedure to be followed for online submission of EMD is as below-

i. Login by Bidder

a. A Bidder desires of taking part in the tender invited by the Corporation shall logon to the e-procurement portal of http://www.wbtenders.gov.in using his login ID and password.

- b. He will select the tender to bid and initiate payment of predefined EMD / Tender Fees for that tender by selecting from either of the following payment modes:
 - i. Net banking (any of the Banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank payment Gateway.
 - ii. RTGS/NEFT in case of offline payment through bank account in any Bank.

ii. Payment by Net Banking (any listed Bank) through ICICI Bank Payment Gateway

- a. On selection of net banking as the payment mode, the Bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.
- b. Bidder will make the payment after entering his Unique ID and password of the Bank to process the transaction.
- c. Bidder will receive a confirmation message regarding success/failure of the transaction.
- d. If the transaction is successful, the amount paid by the Bidder will get credited to the concerned pooling account maintained with the Focal Point Branch of ICICI for collection of EMD/Tender Fees.
- e. If the transaction is failure, the Bidder will again try for payment by going back to the first step.

iii. Payment through RTGS/ NEFT

- a. On selection of RTGS/NEFT as the payment mode, the eprocurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
- b. The Bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his bank account.
- c. Once payment is made, the Bidder will come back to the eprocurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
- d. If verification is successful, the fund will get credited to the concerned Pooling account maintained with the Focal Point Branch of ICICI Bank for collection of EMD/Tender Fees.
- e. Hereafter, the Bidder will go to e-procurement portal for submission of his bid.
- f. But, if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

iv. Refund of Earnest Money Deposit

The Earnest Money of all unsuccessful bidders will be refunded by the WBSFP&HDCL within 30 days from the date of finalization of tender. In case of successful bidder, the Earnest Money will be released after 90 days from the date of the first remittance of royalty to the WBSFP&HDCL. No interest on Earnest Money will be paid by the Corporation.

v. Forfeiture of Earnest Money Deposit will be mandated under the following circumstances

- a. Withdrawal of bid, while bids are under consideration during the tendering period.
- b. Any unilateral revision made by the Bidder during the valid period of offer.
- c. Failure to accept the "Letter of Intent" or execute the Agreement.
- d. Failure to execute supply of the entire order or part thereof.
- e. Providing false or fabricated information / documents.

vi. Clarification of Bidding Document

- a. If there is any discrepancy or obscurity in the meaning of any clause of the bid document or if there is any query of the intending bidder, the bidder shall set forth in writing such discrepancies, doubt, obscurity or queries and submit the same to the Corporation marked to the 'MD, WBSFP&HDCL' prior to the date fixed for prebid meeting.
- b. The queries may be sent by email also to wbsfphdcl@gmail.com up to one day before the date fixed for pre-bid meeting.
- c. The queries received by email up to one day before the date fixed for pre-bid meeting only shall be considered for response.
- d. Verbal queries will be accepted on the day of the pre-bid meeting.

 After the pre-bid meeting no query shall be entertained.
- e. The clarification given in response to the queries and issues raised in the pre-bid meeting shall be in the form of a Corrigendum/Addendum and shall be final and binding on the bidder.

vii. Amendment of Bidding Document

At any time, prior to the deadline for submission of bids, WBSFP&HDCL may, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents by issuing amendments. Any such amendment shall form the part of the bidding document. Such amendments and clarifications in response to pre-bid meeting will be published on the same website and also on the website of the Deptt. of Food Processing Industries Horticulture(http://www.wbfpih.gov.in).Prospective bidders are requested to visit the above mentioned websites on a regular basis to keep abreast of any news. WBSFP&HDCL will bear no responsibility or liability for bidders failing to do so.

In order to afford the prospective bidders reasonable time in which to take the amendment into account in preparing their bids, WBSFP&HDCL may extend the deadline for submission of bids. Such amendments, clarifications etc. shall be binding on the bidders and will be given due consideration to the bidders while they submit their bids and invariably enclose such documents as a part of the bid.

viii. Penalty for suppression / distortion of fact

If any bidder fails to produce the original hard copies of the documents (especially Credential Certificates and audited balance sheets), or any other documents on demand of the Tender Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the bidder will be suspended / debarred / blacklisted / disqualified from participating in the tenders of the WBSFP&HDCL and the Department of Food Processing Industries and Horticulture for a period of 3 (Three) years. In addition, his Earnest Money and Security Deposit as Deposited will stand as forfeited. Besides, WBSFP&HDCL may take appropriate legal action against such defaulting bidder too.

TERMS & CONDITIONS

- 1. The tender shall be accompanied by interest free **EMD of Rs.2,00,000**/- (Rupees two lakh only) in online mode only.
- 2. The successful bidder shall remit interest free **Security Deposit of Rs. 700000/-** (**Rupees seven lakh only**) to WBSFP&HDCL within 15 days from the date of receiving the WBSFP&HDCL 's offer for signing of Agreement. EMD of the successful bidder will be adjusted against the Security Deposit. Failure to remit the Security Deposit within specified time will result in forfeiture of EMD and withdrawal the offer
- 3. The successful Agency shall at his cost execute an Agreement with WBSFP&HDCL on non-judicial stamp paper as per the Terms & Conditions, sign each page of the Terms & Conditions and submit the same to WBSFP&HDCL in two original documents along with the Security Deposit.
- 4. Agency's failure to operationalize the facility within 120 days of the signing of the Agreement shall result in the cancellation of the Agreement and forfeiture of the Security Deposit.
- 5. The Agency shall pay the royalty to WBSFP&HDCL on quarterly basis in equal installments.
- 6. All inputs required for production including the protocol for production and manpower will be procured by the Agency at its own risk and cost.
- 7. The Agency should also take care of all the legal formalities connected to the labour, and other matters associated with the production of tissue culture plant. WBSFP&HDCL will, in no way, be responsible for any consequence arising out of any defaults by the Agency.
- 8. The production will be undertaken by the Agency under its own supervision and involving its own staff.
- 9. The WBSFPHDCL shall post its employee at the Ayeshpur TC Facility to oversee the compliance of the Agreement.
- 10. All available infrastructure i.e. power connection, water connection, available building, Poly houses etc. shall be handed over to the Agency and Agency shall be

responsible for running maintenance and operation expenses. All the expenses in respect of above utilities shall be paid by the Agency.

OTHER CONDITIONS

- 11. The bidder shall be responsible for payment of GST and other taxes, if any.
- 12. At the end of the contract, the Agency shall handover the Ayeshpur TC Facility along with other fittings etc. in good condition. In case of any damage to the permanent fixture and equipment, buildings etc. the Agency shall make good the losses. In such case WBSFP&HDCL may deduct the amount from the Security Deposit /pending payments etc. lying with WBSFP&HDCL. However, the movable items (i.e. Autoclave, Laminar Floor Bench, Glassware etc.) brought by the agency for running the Lab may be taken back by them without damaging the permanent structure.
- 13. WBSFP&HDCL reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
- 14. Conditional offers shall not be accepted and the bidder shall not impose any additional conditions whatsoever.
- 15. In the event of any question/dispute or difference arising between WBSFP&HDCL and the supplier on any matter covered by these Terms & Conditions or arising directly or indirectly there from or connected with these Terms & Conditions in any manner, the matter shall be sorted out between the Managing Director, WBSFP&HDCL and the Agency and in the case of non-resolution of dispute the matter shall be referred to the ACS/Pr Secretary/Secretary of the Department of Food Processing Industries and Horticulture. When at this level the dispute is not resolved, the dispute would be referred to a sole Arbitrator appointed jointly by the two parties and his award shall be treated as final.

The High Court at Calcutta alone shall have jurisdiction to adjudicate thereon.
