Filled in Application, in the prescribed format, along with the self attested copies of all Credentials/Documents mentioned in SL .No. 1, 2, 4, 5&11 including the Earnest Money of Rs.2000/- drawn in favour of West Bengal State Food Processing & Horticulture Development Corporation Ltd in the mode of Pay Order/Bank Draft are required to be delivered in person to the Account Section of this Corporation latest by the last date and time of submission of application i.e. upto 3 P.M of 31st December'2020.

TERMS & CONDITIONS

1. Experience

The applicant must have the experience in selling of consumer products for a period of minimum three years within the territory for which he has applied.

Social Profile

Since young/enterprising people will be more adaptive to the changing scenario, so, for a long term stability in that territory, the people having an age between 18-50 years and appeared/passed Higher Secondary Examination may apply for appointment of distributor.

3. Infrastructure

The applicant must have the sound infrastructure viz. Go-down space, delivery mechanism, skilled man power for reaching out the prospective retailers etc. with required quantity and quality.

4. Financial Status

The Bank statement showing the balance of at least Rs.100000/- on the last date of application or Audited Balance Sheet for the last financial year in case of Firm/Company.

5. Legality of application

Applicants must have the 6(six) Certificate viz. 1) Trade Licence 2) Valid PAN Card 3) Registration Number of GST 4) Bank Account particulars mentioning the Account No, Branch Name and IFSC Code 5) Memorandum of Association/ Partnership Deed(wherever applicable) 6) Aadhaar Card/EPIC.

6. Quarterly sales target

The product of at least Rs.40,000/- should have to be lifted on monthly basis maintaining proper product inventory and order shipment inventory regularly.

7. Transportation

The distributor has to pick up the goods from the Go down of Manufacturer and arranged to transport the same to the downstream channels at his own arrangement.

8. Requisition and Payment

The Distributors are to place the requisition for materials is before the West Bengal State Food Processing & Horticulture Development Corporation Ltd. at least 7 days before the intending date of delivery. On receipt of requisition the order of delivery will be issued in favour of the requiring Agency , who has to collect the intended materials from the Go down of the Manufacturer on payment of 60% of the assessed price of the requisitioned items through Pay Order/Bank Draft drawn in favour of the West Bengal State Food Processing & Horticulture Development Corporation Ltd.

9. Publicity

The distributor will encourage push selling for attaining the sales target. He will provide strategic support to the downstream channel with the publicity materials as received from West Bengal State Food Processing & Horticulture Development Corporation Ltd.

10. Restriction

The distributor will regulate, manage, develop lower tier channel and ensure that they may not be involved in activities that can disturb the marketing order and the price system.

11. Business Plan

The applicant has to submit a business plan and marketing strategy devising the proposed distribution models.

12. Area

The applicant should categorically mention the area of coverage. If the area/ location of two different districts are chosen, then the order of preference should be mentioned categorically.

13. Contract Agreement

The prospective distributor must meet the mutually agreed annual sales quota. The Corporation will reserve the right to adjust the sales quota based on market demands. The potential distributor will be equipped with the binding contract. The newly appointed distributor will be evaluated annually against the requirements stated on the contract. If the distributor fails to fulfil the requirements as stated on the contract, the distributorship will be re-assessed for possible termination.
