- 2.2. Fixing of issues/bugs/minor modification (front end/ backend/ DB/ SMS/Email) without modifying existing process flow.
- 2.3. Bug fixing to comply issues raised during security audits as per the guidelines issued by the Government of India from time to time.
- 2.4. The vendor will be responsible to resolve the vulnerabilities identified by the Vulnerability Assessment (VA) report every 3 months and Penetration testing (PT) reports as and when generated. Also, all the vulnerabilities raised by Cert-IN or NIC related to Security Clearance have to be fixed by the Vendor during the contract within the specified timelines.
- 2.5. Protection against defacement and hacking of the web application and implement security features to protect the site from session hijacking, SQL injection, Cross scripting, Denial of Service etc. In case of a virus or hacking attack, the Vendor shall have to re-create/restore the Website within 8 hours of SLA when the hardware and backup are provided.

- 2.6. Maintenance & checking for dead links/broken links of static pages
- 2.7. Application and Database backups/logs should be monitored daily and resolved if any issues are raised.
- 2.8. The audit trails/logs should be maintained for audit purposes.
- 2.9. The Vendor is required to make updates/changes to the existing developed website only after seeking formal approval from Department of FPI&H/Directorate of FPI
- 2.10. **Implementation of new functionalities:** Engaged/empanelled agency shall have to submit an estimate (financial with timeline) for development, testing and hosting for approval of the Department of FPI&H/Directorate of FPI. Work order to be issued separately on approval of the authority. This shall not come under periodic maintenance/support activities.
