INTRODUCTION

The agro and food processing industries sector is one of the largest in terms of production, consumption, export and growth prospects. This sector ranks fifth in the country in size, employs over 1.6 million workers (20% of the nation's labour force) and accounts for 15.19% of total industry output with 5.5% of the GDP. India's growing domestic demand for value added processed foods and its self-sufficiency in supply is the contributing factors for the growth of this sector. It is estimated that the Food Processing Industry in India will attract phenomenal investment - capital, human, technological and financial- of over Rs. 1,40,000 crore in the next decade.

The state of West Bengal is a significant producer of many horticulture and agriculture produce. The state has achieved significant growth in agriculture production over the past decade (CAGR of 4.5% during 1996-2001). The state accounts for nearly 20% rice, 28% potato & 27% pineapple out of the national production. While there has been a spectacular rise in food grains production over the years, only 1% of the total production is utilized for processing and the post harvest loss accounts for nearly 30%. The State has attained self-sufficiency in food production with reasonable amount of marketable surplus for most of the key crops and fast emerging as the "Food Bowl" of the country.

The wide raw material base and market surplus give the State a natural advantage to invest in Fruit and Vegetable Processing, Spices and Grain Processing Industries. Besides this, the state also produces other Food Products like fish, meat and poultry products in abundance, which also has enormous processing prospects. The Eastern & Northeastern regions have an easy access to bordering countries like Bangladesh, Nepal, Myanmar and Asia-Pacific region for exports.


