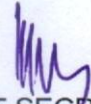
Corrigendum Order

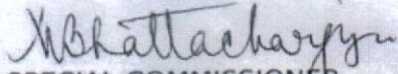

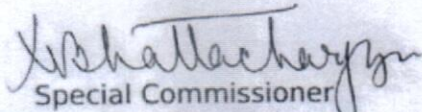
