NOTIFICATION

No.486/FPI&H/1E-44/08 dated 4th May, 2009. - In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor is pleased hereby to make the following rules regulating the recruitment to the posts of (i) Director of Food Processing Industries (ii) Deputy Director of Food Processing Industries/Zonal Officer of Food Processing Industries (iii) Assistant Director of Food Processing Industries/ Assistant Zonal Officer (iv) Food Processing Development Officer & (v) MIS In-charge in the Department of Food Processing Industries & Horticulture, Government of West Bengal :-

RULES

The method of, and the qualifications required for recruitment to the posts of (i) Director of Food Processing Industries (ii) Deputy Director of Food Processing Industries/Zonal Officer of Food Processing Industries (iii) Assistant Director of Food Processing Industries/Assistant Zonal Officer (iv) Food Processing Development Officer and (v) MIS In-charge in the Department of Food Processing Industries & Horticulture, Government of West Bengal shall be as detailed below :-

| (3) Qualifications for direct recruitment | : | (a) Essential
(i) A first class post-graduate degree or second class post-graduate degree with a first class bachelor degree in Food Technology, or Food & Biochemical Engineering from a recognized University or Institution; |

- (ii) At least 16 (sixteen) years full time experience in Food Processing Industries either in Government Sector or Public Sector Undertaking;
- (iii) Adequate administrative experience in Food Processing Industries and administrative ability;
- (iv) Knowledge of Bengali/Nepali - Spoken and Written.
- (b) Desirable :
Training on Quality Management and Packaging in Food Processing Industries.
- (4) Age for direct recruitment : Not more than 54 years on the 1st day of January of the year of advertisement.
Provided that the age limit shall be relaxable for candidates having higher qualifications or longer experience than those prescribed or for the candidates holding substantive appointment under the Government of West Bengal or the Government of India.
2. (1) Name of the Post : Deputy Director of Food Processing Industries / Zonal Officer of Food Processing Industries.
- (2) Method of recruitment : By promotion, in consultation with the Public Service Commission, West Bengal, from amongst the officers holding the post of Assistant Director of Food Processing Industries or Assistant Zonal Officer of Food Processing Industries, having five years' service in the post as such;
Or
By deputation of an officer holding analogous post under the Government of West Bengal or the Government of India.
3. (1) Name of the Post : Assistant Director of Food Processing Industries / Assistant Zonal officer of Food Processing Industries.
- (2) Method of recruitment : By selection (direct recruitment) through the Public Service Commission, West Bengal;
Or
By deputation of an officer holding analogous post under the Government of West Bengal or the Government of India.
- (3) Qualifications for direct recruitment : (a) Essential
(i) A bachelor degree in Food Technology from a recognized University or Institutions;

- (ii) At least 2(two) years full time experience in promotion and development of Food Processing Industries either in Govt. Sector or Public Sector Undertaking or Institute of repute;
- (iii) Adequate knowledge in Food Processing Industries;
- (iv) Knowledge of Bengali / Nepali - Spoken and Written.
- (b) Desirable:
- (i) Training on Entrepreneurship Development, Training on Quality Certificate;
- (ii) Promotion of Food Processing Industries.
- (4) Age for direct recruitment : Not more than 32 years on the 1 st day of January of the year of advertisement;
- Provided that the age limit shall be relaxable for candidates having higher qualifications or longer experience than those prescribed or for the candidates holding substantive appointment under the Government of West Bengal or the Government of India.
4. (1) Name of the Post : Food Processing Development Officer.
- (2) Method of recruitment : By selection (direct recruitment) through the Public Service Commission, West Bengal ;
- Or
- By deputation of an officer holding analogous post under the Government of West Bengal or Government of India /Public Sector Undertakings.
- (3) Qualifications for direct recruitment : (a) Essential :
- (i) Diploma in Food Technology/Degree in Bio-Technology /Diploma in Refrigeration Engineering from any recognized University;
- (ii) Experience in service at least 3 (three) years in production of food products in any reputed organization and knowledge in quality testing and cold chain management ;
- (iii) Knowledge of Bengali / Nepali - Spoken and Written.
- (b) Desirable :
- Basic Computer Knowledge.

(4) Age for direct recruitment : Not more than 32 years on the 1st day of January of the year of advertisement;

Provided that the age limit shall be relaxable for candidates having higher qualifications or longer experience than those prescribed or for the candidates holding substantive appointment under the Government of West Bengal or the Government of India.

5. (1) Name of the Post : MIS-in-Charge.

(2) Method of recruitment : By selection (direct recruitment) through the Public Service Commission, West Bengal;

Or

By deputation of an officer holding analogous post under the Government of West Bengal or Government of India / Public Sector Undertakings.

(3) Qualifications for direct recruitment : (a) Essential :

(i) Master Degree in Computer Science / BE. or B.Tech. in Computer Science or Information Technology from any recognized University or Institution;

(b) Experience :

At least 1 (one) year experience in Programming, preparation of financial analysis, Profit & Loss Account, Cash Flow and Data Processing.

(4) Age for direct recruitment : Not more than 32 years on the 1st day of January of the year of advertisement;

Provided that the age limit shall be relaxable for candidates having higher qualification or longer experience than those prescribed or for the candidates holding substantive appointment under the Government of West Bengal or the Government of India.
